*Vacant positions

Should a position become vacant mid-term, a member may be voted in to casually fill the vacant position (Acting Position Holder). The position will be held until the end of that term of office when the position will be open to nominations. The member who acted in the position is eligible to nominate for the position and the period in which they acted will not be deducted from their first term. A person chosen to fill any vacancy among the Executive Officers will meet the qualifications.

(E) Executive Committee position

Qualifications for Executive office:

- a. Demonstrating faithful adherence to the Twelve Steps of OA, the Twelve Traditions of OA and the Twelve Concepts of OA service for at least 12 months
- b. And a member of an active group for a period of at least 6 months, preferably 12 months c. To be or have been an Intergroup Representative and/or a Committee Co-ordinator for at

least 6 months, preferably 12 months

And having at least 3 months, preferably 6 months current and continuous abstinence.
